• Fire, Elementary School - 2023

As project lead, Evan established a comprehensive scope of work, pricing structure, and period of restoration for a severely fire-damaged elementary school where over 50% of the building sustained catastrophic damage. Working in close collaboration with structural engineers, environmental hygienists, and local education authorities, he coordinated safety protocols and abatement procedures while ensuring compliance with educational facility regulations. His detailed damage assessment and accurate cost projections facilitated efficient claim resolution, with total repairs valued at \$8M, while restoration timelines aligned with the district's educational calendar requirements.

• Tornado, City Waste Treatment Facility - 2023

Evan provided comprehensive valuation, reconstruction consultation, and estimation services for water treatment and distribution systems severely damaged by a tornado. Since the project encompassed multiple critical infrastructure components including wastewater treatment facilities, raw water treatment systems, water towers, and pump stations, he worked as primary liaison between municipal authorities, engineering teams, and environmental specialists. Having conducted a thorough assessment of structural damage and system interruptions, Evan coordinated with contractors and equipment vendors to develop detailed cost projections and restoration timelines that minimized service disruptions while ensuring compliance with environmental regulations and municipal standards, with total project costs estimated at \$11M.

- Hurricane Ian, Retirement Community - 2022
Managing a team of consultants and oversight of CAT parameters, Evan coordinated comprehensive inspections and damage assessments across a 195-location mixed residential complex impacted by Hurricane Ian. The project scope encompassed diverse property types including hospital facilities, a golf course, restaurants, single-family dwellings, and low-, mid-, and high-rise apartment buildings, along with common areas and a central chiller system. Evan directed a systematic evaluation of wind-related damages, coordinating with structural engineers and mechanical systems specialists to assess building integrity, HVAC infrastructure, and property-wide utilities. Working closely with carriers, property management, and local authorities, he established mitigation protocols and developed accurate repair estimates that addressed both immediate safety concerns and long-term restoration requirements while significantly reducing business interruption for the retirement community's operations.
