- **Wildfire, Altadena, CA - 2025**
Serving as primary consultant for a large-loss event exceeding \$4M, Anthony directed structural analysis, scope validation, and comprehensive reconstruction cost modeling for a severely impacted healthcare facility. Managing a multidisciplinary team, ensured strict adherence to reconstruction code upgrades, mitigation protocols, safety and environmental considerations. The structure required re-inspections over several occasions, and Anthony coordinated with engineers, the carrier, emergency services, and abatement experts to update and oversee repair and building preservation within compliance for all stakeholders. His expert oversight of project timelines and financials lead to reduced costs, and combined with hands-on management and regulatory compliance, he ensured efficient claim resolution.
- **Theft & Vandalism, Los Angeles, CA - 2024**
A complex theft and vandalism claim involving a vacant commercial high-rise is where Anthony concentrated his expertise and evaluated damages exceeding \$2M. He collaborated alongside mitigation contractors, engineers, and hygienists to develop a detailed loss assessment, ensuring all restoration schedules and budgets adhered to business interruption protocols within established NTE thresholds. Equipped with a strategic approach through detailed research, Anthony facilitated accurate scope development, expert budgeting, and timely project completion.
- **Fire, White Bluff, TN - 2023**
Functioning as the project supervisor for a high-net-worth residential fire loss exceeding \$3.8M, Anthony conducted scope comparison, estimate review, and site documentation as part of his findings. He partnered with hygienists, municipal workers, engineers, and abatement teams to address safety and environmental concerns, while managing abatement and debris removal budgets and timelines. - **Theft & Vandalism, Los Angeles, CA - 2022**

As senior consultant, Anthony assessed a vandalism loss, estimated to be over \$500K, at a commercial property and prepared detailed analysis of structural damage and mitigation scopes. Coordinating with contractors and forensic specialists, he validated incident details, developed restoration estimates, and oversaw emergency repair and building preservation. His efforts ensured all work remain aligned with mitigation plans and NTE limits, supporting objective outcomes for all stakeholders.

- **Wildfire Smoke, California - 2020 to 2022**

Across four counties over the course of more than 100 wildfire smoke-related claims with estimated values up to 100K, Anthony provided expert construction consulting. Whether on scope validation, estimate preparation, or mitigation oversight, he worked in tandem with engineers, hygienists, and abatement teams. To address safety and environmental concerns, each project adhered to strict timelines and financial controls. His comprehensive approach by communicating with county supervisors, general contractors, local emergency services, as well as logistics experts for delivery of materials all minimized business interruption and facilitated an expedited claim resolution.

- **Water, Portland, OR - 2020**

A popular hotel chain experienced a water loss exceeding \$1M, and Anthony directed emergency repair and building preservation efforts, collaborating with mitigation contractors and hotel management to ensure continuity of operations. He managed mitigation schedules, abatement and debris removal budgets, coordinated with engineers to validate scope, and maintained project timelines within 'not to exceeds.' Leading with clear expectations and communicating the scope to all parties, Anthony ensured efficient restoration and minimized disruption to both business operations and hotel guest experiences.

- **Fire, Tulare, CA - 2020**

Guiding the project team of three consultants with clerking, Anthony reported on documentation, scope validation, and coordination with contractors and engineers during multi-tiered inspections for a reconstruction site with a loss estimate exceeding \$8M. He ensured adherence to mitigation strategies, managed abatement budgets, and maintained compliance with safety protocols while keeping open communication with county leadership, agricultural experts, hygienist teams, and emergency services. The insured, carrier, and the adjuster supported estimates from Anthony's accurate outcomes which contributed to the successful and timely restoration of a large-scale loss.
