FEATURED PROJECTS

- Wildfires, Altadena, CA - 2025
Having led post-wildfire restoration for 20 damaged structures across the Mendocino and Mariposa campuses at the Pasadena Waldorf School, Brett collaborated with environmental consultants and industrial hygienists. Hazardous conditions were properly mitigated while maintaining full regulatory compliance, and his efforts resulted in a thorough damage assessment and comprehensive scope of work valued at \$13.2M. By streamlining insurance negotiations and accelerating the recovery process, Brett helped projects move forward efficiently and safely. Coordination across multidisciplinary teams became a lifeline, striving to restore safety and stability where students' routines and learning had been upended.
- Wildfires, Altadena, CA - 2025
As the project's lead consultant, Brett directed restoration efforts for 8 high-net-worth residences within the luxury condominiums at Sunset West HOA. Across engineering and environmental teams, he facilitated coordination to address hazardous conditions and execute hazmat testing protocols. Within strict NTE thresholds, abatement budgets and debris removal plans were developed under Brett's oversight. Supporting insurance negotiations, his scope documentation and cost analysis, valued at \$18.2M, ensured alignment with mitigation strategies and continuity goals giving a sense of closure for the displaced residents.

FEATURED PROJECTS CONTINUED

- **Wildfires, Lahaina, HI - 2023**
Brett led the strategic recovery of over 80 fire-ravaged condominium units at Aina Nalu resort complex following the devastating wildfire event. Coordinating engineering teams and environmental specialists to assess damage and develop a restoration framework, he produced a comprehensive scope of work and established an accurate repair estimate totaling \$22.5M. Aligning with carrier expectations and facilitating efficient claim resolution, Brett's oversight extended to inspection logistics, hazmat coordination, and mitigation planning, ensuring regulatory compliance and operational continuity. His ability to manage stakeholder communication and align restoration protocols within strict budgetary constraints allowed communities to regain their vital infrastructure and recover a sense of normalcy after devastation.
- **Tornado, Temple, TX - 2023**
Extensive tornado damage called to Brett's expertise serving as the project's lead consultant. While partnering with both CRC, for debris removal, and F&F Construction, for managing restoration, Brett completed a full-spectrum damage assessment working closely with municipal and county authorities to develop a defensible scope of work valued at \$1.3M. His oversight ensured alignment on removal and repair protocols with a hygienist team, timeline execution with engineers and GCs, and clear communication of carrier expectations to facilitate efficient claim resolution and operational recovery.
- **Tornado, Wynne, AR - 2023**
Following an EF-3 tornado, Brett conducted comprehensive inspections across 30+ municipal properties, including the severely impacted sewage treatment plant. He performed a full-spectrum abatement and debris removal assessment and developed detailed scopes of work for critical infrastructure restoration. Collaborating with local authorities, Brett established emergency repair protocols and ensured regulatory compliance with state and local authorities. The total project estimate exceeded \$9M, with Brett's leadership driving timely recovery and stakeholder alignment.
- **Fire, Savannah, GA - 2023**
Brett provided expert oversight for post-fire restoration at a commercial site, managing mitigation review, asbestos abatement evaluation, and detailed invoice reconciliation. He collaborated with environmental specialists to ensure compliance with safety regulations and industry standards. Brett possessed a fresh understanding of building standards, material usage, and market costs allowing for meticulous documentation review and cost verification which supported defensible scope development and carrier alignment for a project valued at \$850K.
- **Hail, Newcastle, OK - 2023**
As chief consultant overseeing the comprehensive evaluation, documentation, and damage assessment initiative, Brett managed a workforce on a tight schedule for over 20 properties impacted by severe hail. He conducted detailed inspections of roofing systems, exterior cladding, and structural components, identifying scope-critical deficiencies. Collaborating with contractors, Brett communicated defensible repair scopes, negotiated agreed pricing, and aligned restoration timelines with carrier expectations. His technical fluency and documentation precision ensured cost accuracy and expedited claim resolution.
