- **Wildfires, Palisades / Eaton Canyon, CA - 2025**
Project lead for 10+ high net worth residences destroyed from wildfires in Southern California. One high profile 15,000SF home featured exotic flooring, an elaborate home theater room, and a custom designed pool and spa area. Navigated extreme access issues due to mountainous terrain. Total estimate valued over \$12M.
- **Wildfires, Lahaina, HI - 2023**
Overseeing more than 55 residential loss cases, Cameron coordinated comprehensive inspections, conducted in-depth interviews with families, and meticulously estimated damages for multi-million-dollar properties including an elaborate sliding glass panel wall system, custom redwood exterior, and a smart house management system. The role involved close collaboration with engineers, environmental experts, and construction teams to address safety and environmental concerns, while also working with carriers, syndicates, and local authorities to establish precise project timelines and budgets with estimated repair costs valued at \$50M. As the primary liaison between syndicate clients and project teams, Cameron ensured accurate budgeting, thorough business interruption assessments, and strict adherence to repair and preservation objectives.

Cameron, in collaboration with a team of consultants, coordinated the inspection and evaluation of over 1,200 loss locations impacted by wind and water damage, with total reconstruction costs surpassing \$40M. The team of 10+ building consultants conducted thorough site inspections, evaluating structural integrity, roofing, water intrusion, and other essential systems. Comprehensive reports were compiled incorporating local construction rates, material needs, and labor costs, ensuring precise replacement estimates and timely claim resolutions to facilitate both immediate and long-term recovery efforts.

- **Hurricane Ian, Placida, FL - 2022**
As the lead consultant, Cameron was responsible for evaluating and documenting over \$15M in damages to a multi-building condo complex, which included wind, water, and debris-related destruction to roofing, windows, and structural elements. Cameron coordinated a team of adjusters and contractors to conduct a comprehensive inspection of both the interior and exterior, identifying damages from hurricane-driven wind, rain, and debris, while defining the scope of work and estimating repair costs. Throughout the process, he worked closely with carriers, syndicates, and local, state, and federal authorities to ensure that abatement and debris removal budgets, construction timelines, and NTE limits were adhered to, allowing for efficient project completion.
- **Winter Storm Uri, Texas - 2021**
Cameron collaborated closely with engineers, environmentalists, contractors, and carriers, while managing claims for over \$4M in damages across a diverse portfolio of commercial buildings, country clubs, churches, and high-net-worth homes throughout Texas. This included overseeing the assessment of 14 buildings affected by freeze conditions, with damages such as snow collapse, freeze stall, water intrusion, and broken pipes. He coordinating with municipalities and authorities to ensure proper mitigation, budgeting, and timelines were maintained, including emergency repairs, drying goals, and business interruption concerns.
- **Tornado, Nashville, TN - 2020**
Cameron led the inspection and estimating for five complex claims, with the total replacement and rebuilding costs surpassing \$6M. His team of 10+ building consultants meticulously assessed structural integrity, roofing systems, exterior components, and any internal impact to each property. Detailed cost projections were developed, factoring in current market rates, labor, materials, and adherence to local building codes, ensuring precise and timely claim resolutions to support efficient recovery and restoration efforts.
