FEATURED PROJECTS

- Hurricane Helene, Valdosta, GA - 2024
In 2024, Carmelo led the damage assessment for eight hurricane-impacted properties as part of a broader catastrophe response effort. He conducted detailed site inspections with insured parties and contractors to evaluate structural damage and formulate precise repair scopes. By facilitating communication between project teams and insurance carrier clients, Carmelo ensured adherence to mitigation plans, construction cost constraints, and business disruption management—all within set NTE thresholds. Through expert budgeting/oversight, coordination of emergency repair, and building preservation efforts, Carmelo was precise while maintaining alignment with abatement/debris removal budgets and timelines.

FEATURED PROJECTS CONTINUED

- **Hailstorm, Victor, NY - 2024**
Following a devastating hailstorm, Carmelo joined a team of five consultants to assess damage across 59 condominium buildings, valued at \$6.5M in total. The storm left residents facing uncertainty and disruption, and he approached each inspection with accuracy and precision—carefully distinguishing between damage and wear across elevations. His documentation, captured in detailed spreadsheets, supported transparent communication with stakeholders and helped restore clarity to the project. He provided scoping support for roof, gutter, siding, and window screen damages, ensuring scope alignment and weather-related event documentation while fostering collaboration across all teams. His work reflected not only technical expertise but also a deep commitment to helping communities recover with a special attention to resident displacement.
- **Water, Long Branch, NJ - 2024**
Carmelo managed the assessment of storm-related water damage at a hospital facility with losses valued at \$500K. The incident, caused by roof intrusion, posed a serious threat to both infrastructure and patient care continuity. He worked closely with mitigation, hygienists, engineers, and repair contractors to conduct a thorough scope review, reaching consensus on scope details and cost estimates. His approach prioritized minimal business interruption while upholding healthcare safety protocols and operational compliance. The project showcased his ability to balance technical precision with the urgency and sensitivity required in healthcare environments.
- **Wildfires, Maui, HI - 2023**
Carmelo secured prompt and successful service as the lead consultant for 24 burned properties encompassing both condominium complexes and high-value residential homes. Due to the total devastated nature of most sites, Carmelo conducted empathetic, off-site interviews with displaced homeowners, often meeting at local supermarkets and cafés, to reconstruct property layouts and collect photographic evidence. He performed thorough site visits to evaluate lot dimensions and environmental conditions, enabling accurate reconstruction estimates and scope development. Carmelo's work reflected strong stakeholder engagement, scope alignment, and CAT event response expertise, while maintaining sensitivity to the emotional and logistical challenges faced by affected residents.

Over the course of 14 years in the restoration industry, Carmelo led numerous projects involving fire, water, mold, and lead damage across a wide range of commercial and residential properties.
