Impacted by smoke infiltration following a parking garage fire, the seven-story structure, including a three-floor garage, was coordinated with the industrial hygienist and restoration contractor to align protocols. Dan developed a detailed scope of work, and produced estimates that adhered to preservation standards appropriate for this landmark institution.
