FEATURED PROJECTS

- **Water, Sacramento, CA - 2025**
Responding to a significant water intrusion event, Mario lead the inspection of the impacted 13,000 SF medical facility, resulting in interior damage and requiring extensive cooperation with a team of engineer, mitigation, restoration, and hygienist crews. Throughout the project with keen oversight, he held the team accountable via abatement/debris removal budgets and timelines, acting as a liaison with parties free to communicate their needs for means and method, drying goals, and NTE limitations to come up with an agreed repair scope of \$300K. Mario facilitated the resolution of multiple disputes across several trades and supported stakeholder perspectives to expedite project completion.
- **Wind / Fire, Los Angeles, CA - 2025**
Catastrophic incidents of wind and fire across the largest metropolitan area in the country called Mario to respond to the needs of his neighbors ranging in widespread roof damage across multiple properties, leading to four projects with subsequent water intrusion and interior damage, total values estimated at \$1.2M. Teaming up with 6+ general contractors along with third-parties, stakeholders, emergency services, municipalities, and a swath of private and public entities during this highly publicized disaster, it was essential to lead with clear and correct information to keep on track all timelines and budgets for abatement, debris removal, hazardous environmental testing, and other risk assessments. Mario conducted detailed damage inspections and facilitated resolution of mitigation and repair costs to support timely claim settlements.

FEATURED PROJECTS CONTINUED

- **Wind, Northern CA - 2024**

Mario spearheaded this project in the wake of widespread wind-related damage across multiple counties, overseeing \$1.8M in assessments for structural compromise, roof failures, and water intrusion. He mobilized field teams to conduct detailed inspections and coordinate emergency mitigation for 11 single-family properties, ensuring safety from fallen trees and continuity for affected properties. Acting as a strategic liaison, Mario promoted dialogue between carriers, contractors, and municipal officials. His technical oversight included scope validation, budget alignment, and documentation for properties throughout the recovery process. Mario's empathetic engagement with property owners helped ease disruption and foster trust, while his operational precision accelerated timelines and minimized secondary loss.

- **Wildfires, Lahaina, HI - 2023**

Mario led the post-catastrophe response for an overwhelming wildfire event, coordinating environmental testing, structural assessments, and community outreach. His engagement with displaced homeowners helped streamline communication with carriers, syndicates, and municipal authorities and expedited claims processing for the 16 single-family residence properties. Additionally, he assessed and estimated an additional \$500k in repairs for 21 HOA bare wall policy claims. Having Mario manage the full lifecycle of mitigation, debris removal, and asbestos abatement, he ensured compliance with Hawai'i FIRE and EPA standards that lead to an estimated rebuild value of \$17M.

- **Fire, Santa Rosa, CA - 2023**

Considering the assessment and restoration of a damaged rectory, in the wake of a destructive wildfire, Mario led the efforts to scope that what was impacted by fire and smoke damage. He managed a team of consultants, engineers, and hygienists utilizing detailed assessments for abatement, pack out, pack back, asbestos abatement, cleaning and repair processes, as well as rebuild cost estimation. As liaison between project teams, municipal authorities, and syndicate clients, Mario ensured mitigation strategies, abatement timelines, and construction budgets remained aligned within reserves. His empathetic engagement with displaced homeowners, combined with expert oversight of environmental and safety protocols, helped deliver timely recovery while minimizing business interruption and preserving structural integrity.

- **Fire, Sacramento, CA - 2023**

Following a fire at an historic district construction site for builders' risk, Mario directed a coordinated response involving scoping, structural evaluation, and a rebuild estimation valued at \$500K. He led a team of consultants, engineers, and hygienists and conducted oversight for demolition planning, while maintaining strict adherence to mitigation budgets and NTE thresholds. Acting as intermediary between project teams and syndicate clients, Mario ensured timely emergency repairs and building preservation, balancing technical expertise with continuous communication to minimize business interruption and restore project momentum.
