FEATURED PROJECTS

- **Wind, Houston, TX - 2024**
Following catastrophic wind damage to over 400 curtain wall panels, Marshall led a team of 20+ consultants to assess and estimate losses at a 43-story commercial tower valued over \$10M. Interior finishes, including granite and marble surfaces across multiple floors, required careful restoration planning. Marshall coordinated mitigation and construction crews, ensuring safety protocols and scheduling remained aligned through project completion.
- **Tornado, Gallatin, TN - 2023**
After a destructive tornado impacted 46 multi-family buildings, Marshall partnered with HOA representatives and engineering teams to evaluate structural and environmental damage. His team inspected each roof using MEWP equipment and replaced 42 of them, while managing emergency repairs and coordinating restoration efforts across all units. The project demanded not only technical oversight of engineering and roof construction but also sensitivity to displaced residents and community disruption.
- **Hurricane Ian, Punta Gorda, FL - 2022**
As Hurricane Ian swept in powerful wind gusts tore through a nearly completed 250,000 SF. FedEx distribution facility, triggering a builders' risk claim. Marshall led the damage assessment, identifying widespread roof membrane failure, compromised HVAC systems, and torn exterior cladding that exposed interior finishes to further deterioration. Wind-driven debris had punctured structural elements and disrupted site grading, prompting erosion control measures and retention pond remediation. Marshall coordinated mitigation and construction teams to stabilize the site, restore critical systems, and ensure continuity of the build, all while maintaining alignment with environmental safety protocols and the scope estimated at \$2.5M.
