- **Wind, Branson, MO - 2023**
As principal consultant, Paul led the strategic response to a catastrophic wind event that resulted in full roof system failure and widespread interior water intrusion at a high-profile entertainment venue. He facilitated complex negotiations between the carrier, two construction firms, and a public adjuster, aligning scope development and pricing within strict NTE thresholds. Paul directed emergency repair and building preservation efforts, ensuring business continuity while maintaining expert oversight of mitigation budgets, restoration protocols, and stakeholder coordination across all phases of recovery.
- **Tornado, Little Rock, AR - 2023**
In the wake of a destructive tornado that left two office buildings fractured, their operations disrupted, Paul led with precision and compassion. He partnered with engineering and construction teams to assess structural damage, valued at \$2.66M, and developed a recovery roadmap that balanced urgency with precision. Acting as the central liaison, Paul ensured seamless communication between stakeholders, facilitating timely inspections and scope alignment. Exemplary leadership by Paul ensured the project remained on track within strict limits, while skillfully navigating the complexities of stakeholder interests and maintaining a steadfast commitment to the well-being of those affected by the loss.

Following a devastating tornado that left a prominent church facility structurally compromised and its congregation displaced, Paul stepped in leading the recovery effort. He collaborated closely with engineering teams and two construction firms to assess the full extent of damage and to develop a restoration plan that honored both the architectural integrity and the significance of the space. Paul managed inspection logistics and streamlined communication between adjusters and stakeholders, ensuring scope alignment, from timely execution to an adherence to mitigation protocols, and developed a restoration scope valued at \$2+M, all while helping restore a vital community anchor.

- **Hurricane Ida, New Orleans, LA - 2021**
In the aftermath of Hurricane Ida, Paul served as senior consultant for the restoration of St. James Parish Hospital, a critical healthcare facility facing structural compromise and operational disruption. He collaborated with engineering teams and two construction firms to evaluate damage and develop a recovery strategy that prioritized patient care continuity. Paul coordinated all inspection activities and facilitated communication between adjusters and stakeholders, ensuring scope alignment, regulatory compliance, and execution within the \$2.3M reconstruction budget.
- **Hail, Sherman, TX - 2023**

He coordinated inspection activities and partnered together with restoration teams and adjusters to define scope and pricing, ensuring expert budgeting/oversight and alignment with mitigation budgets, abatement timelines, and construction cost constraints.
