



## **FEATURED PROJECTS**

- Wildfires, Lahaina, HI 2023 Following catastrophic wildfires, Tim collaborated with municipalities and federal, state, and local authorities to develop comprehensive reconstruction estimates. He directed consultants, engineer crews, and environmentalist teams to perform hazmat testing, demolition, and rebuild estimates in the assessment and documentation of multiple commercial and highend residential properties, including a large grocery store and a multi-site commercial complex. Having oversight with abatement/debris removal budgets and timelines, he helped diminish business interruption and construction cost constraints, all within set NTE thresholds, while maintaining continuous contact with the project teams through completion to ensure adherence to RMC's rigorous reporting standards. Creative management resulted in detailed reporting packages giving valuable information regarding budgets, engineering assessments, vendor services, photographic documentation, and reconstruction estimates to all stakeholders.
- Processing Facility, Tacoma, WA 2022
   Tim led a team of consultants to thoroughly inspect a processing plant site and develop accurate reconstruction estimates valued at \$3.7M. By prioritizing business continuity, Tim simultaneously managed debris removal/abatement activities alongside reconstruction efforts to minimize operational disruption. Understanding that there was significant damage to multiple buildings, he reached out to emergency teams and coordinated closely with carriers, engineers, and reconstruction crews to ensure optimal scheduling and budget adherence for achieving consensus on the project's scope and valuation.

Industrial/Hazardous Waste Process, Grand View, ID
 2018

Managing emergency repair and environmental crews for a hazardous waste treatment facility spanning 65+ acres, Tim conducted a comprehensive damage evaluation and provided expert oversight during post-catastrophic reconstruction. He served as liaison for safety concerns during the extensive process and coordinated mitigation/abatement protocols to facilitate safe hazmat neutralization for damaged processing structures. This allowed Tim to gain management over supervised construction budgets, mitigation timelines, and debris removal operations to ensure project completion within established parameters.

 Hurricane Response, Southeast United States - 2016-2017

In the aftermath of the devastating storms, Tim provided expert budgeting and oversight services for large commercial property assignments. With damage assessments, scope development, and cost estimating being completed, he coordinated assets and oversight for multiple affected properties. When he worked with teams of engineers and environmental specialists to address structural integrity concerns and remediation requirements, Tim was able to establish effective communication channels with carriers and property owners facilitating timely and agreed resolutions.

 Catastrophic Storm Response, Gulf Coast - 2004-2005

In the wake of each of the hurricanes, Charley and Katrina, Tim developed comprehensive scopes of repair and detailed cost estimates for severely damaged properties across multiple sectors. His workload ranged from managing complex commercial property assessments to ensuring multiple disciplinary teams were following the correct strategic mitigation protocols to prevent secondary damage and reduce business interruption. This led to a working relationship with local authorities and building officials to ensure code compliance throughout the restoration process.
